THE DIALECT OF BIKOL SPOKEN IN NAGA CITY, THE PHILIPPINES, IS DESCRIBED IN THIS SHORT ANALYSIS OF THE MOST BASIC BIKOL STRUCTURAL PATTERNS. IT IS ASSUMED THAT THE READER HAS LINGUISTIC TRAINING OR IS A STUDENT OF BIKOL (SEE ALSO AL 000 502, "BIKOL LESSONS"). PHONOLOGY AND DIALECT DIFFERENCES ARE VERY BRIEFLY DISCUSSED. EXAMPLES ARE GIVEN FOR EACH GRAMMAR POINT. (JD)

#### STANDARD BIKUL

The kind of bikel which is understood, respected, and acceptable throught the Bikel provinces is that speken in Naga City and certain other areas (including Legazpi City). This is "Standard Bikel," referred to by the people of the Bikel provinces as "pure" Bikel, "national" Bikel, and "Naga" Bikel, since it is most readily associated with the speech of people from Naga City in Camarines Sur.

The grammatical description which fellows is an attempt to describe only the most basic structural patterns of Bikel as it

is spoken in Legazpi and Naga.

#### DIALECT AREAS

Bikel dialects can be roughly divided into six areas:

- Standard Bikel, speken through-out Camarines Sur (<u>except</u> for the Rinconada section), easternmest Albay, and four municipalities in Sersegon. In Camarines Norte, although Standard Bikel is speken in some areas, Tagalog is dominant. Daet, it is said, is half Tagalog-speaking and half-Bikel-speaking.
- (2) The Rinconada dialects of Bula, Buhi, Baao, Nabua, 3040, and Iriga, clustered together in the southern base of Camarines Sur.
- (3) Northern Catanduanes
- (4) Southern Catanduanes

- (5) The Central and western sections of Albay
- (6) Sersegen, pertiens of which have been much influenced by Waray-Waray from neighboring Samar.

The language and dialects of Masbate are basicly Visayan, with the major influence being Cebuane.

#### DIALECT DIFFERENCES

The major differences between Adialects are <u>lexical</u> first, and then <u>phonological</u> differences (largely intenation patterns). The structural <u>patterns</u> remain, generally, much the same, with occasionally alternate forms with identical functions, e.g. NAGAin Daraga fundtions the same as NAG<sup>+</sup>cv. Lexical items, differing among various dialects, which will cause the most trouble diearning will be those items of extremely high frequency, such as words for negation, deictics, demonstratives, function words (subject markers, geal markers) etc.

#### LITERARY BIKOL

There is a particular kind of Bikol, called Deep Bikol (<u>hararom na Bikol</u>) by Bikolanos, which stands apart from the colloquial speech of everyday use. This literary Bikol, with its special vocabulary and structures reserved for its uses, will be found in writing, speeched, "novenas," poetry, and used by people in their seventies and upwardm. In a (Moder Maked) speech, for example, BALAKID might be used for DAKUL, the colloquial form; HULI TA for TA (because), ASIN (and) for SAKÁ/BUDÁ (and), etc.

#### ON BIKOL DIALECTS

The following was taken from an article written for the Hicol Teachers' College student magazine. It was written by Miss Iluminada Bite, whose junier year phonetics students have gathered, over a five-year period from 1962 to 1967, an impressive six volumes analyzing the phonology of Bikel dialects in seventy-eight Bikel-speaking towns.

The analyses of the Bicol spoken in the aforementioned (78) towns which were done with great interest by the students to the satisfaction of their instructor, showed that the Bicol segmental phonemes include: 16 to 17 consonants, 3 to 6 vowels, and 4 to 8 dipthongs. The consonants common to most of the Bicol varieties are: /b k d g h l m n ng p r s t w y >/. A unique voiced velar sound, which is a cross of the /g/ and the /y/ sounds, is found only in Buhi. The /y<sup>⊥</sup>/, a dental-palatal sound which is a cross of the /y/ and the /l/ sounds, is found in the towns of Virac, Bate, Baras, San Miguel, and Gigmete, in Catanduanes.

The vowels common to most varieties are: /i e a  $\circ$  u/. A sixth vowel is found in the dialects of Daraga, Camalig, Jovellar, Guinebatan, Pieduran, Ligao, Oas, and Polangui, in Albay; Donsol, in Sorsogon; and Buhi and Iriga, in Camarines Sur. This vowel is produced in the same point in the mouth as the English /U/ in book, but the lips are spread rather than slightly produced. Other findings about Bicol vowels are that the Nabua dialect has only three vowels: / i a u/; Daraga, Guinebatan, Donsol, Buhi, and Iriga, have four: /i a u U\*; Polangui has five: /i a  $\circ$  u U\*; and Camalig, Ligao, Oas, and Jovellar have six: 7 i e a  $\circ$  u U\*.

The common dipthongs are? /iw aw ay oy uy/. The dialects that have the /U\* / sound have other dipthongs that involve this sound. Buhi has a unique dipthong sound that involves the special consonant in its sound system, found in its term for <u>astuma</u>. Virac and other towns that have the /y / sound have the additional dipth ngs/(ay<sup>1</sup>/, found in /bagey<sup>1</sup>/, meaning caconut shell; and /ayl/ found in /kuday /, meaning fence.

Consonant clusters are very rare in Bicol. The few that occur in initial position are: /bl br bw by kl kr kw ky pl pr pw py dr dw dy gl gr gw tr ts tw ty sw sy rw ry lw ly mw hw/. The majority of these are found in words borrowed from English or Spanish. Some of these occur in the dial position when a prefix, like ka-, or mag-, is used in the word. Examples are: /kaklase/, meaning "classmate"; and /mag-pyane/, meaning "to play the piano.".

Consonant clusters never occur in final position. Only in the speech of those whose knowledge of English pronunciation is quite good will one hear a final consonant cluster in words adopted from English.

The suprasegmental phenemes presented in the comparative charts are practically the same for all the varieties of Bicol.

#### Phonology of Standard Bikel

Since /e/ does not contrast minimally with /i/, it could also be presented as an allophone of /i/. In the dialects that use /e/ (many areas substitute /i/ for /e/) the sound is usually represented by "e" in the orthography: KAHÉRAK (pity), MAHALE (go out).

Since /u/, similar to "bee", does not means contrast minimally with allophones /u/ or /o/, then it too could be presented as a third allophone of /u/. This sound /u/ is generally required when the accepted orthography uses "u:" DAKUL (much, many), GULPI (plenty), UTANG (berrow).

STRESS; Bikel differentiates between strong stress and weak stress. In the fellowing grammatical description strong stress is marked / //.

// signals strong stress followed by a glottal stop:

# SIRÂ (fish)

## SAKĜ (mine)

/// signals primary stress on the penultimate syllable and a glottal stop on the marked syllable:

NAMONDÙ (get sed)

NABUTA (went blind)

Between vowels a hyphen / - / signals a glottal stop:

ANÍ-ON (here)

KA-AN (that)

In standard erthegraphy such words are written ANION, KAAN. A few words have been transcribed with no indication of a glettal step: IN DAI (DA-I), TATAO (TATA-O).

Where a vowel is reduplicated it is assumed there is a glottal , stop between them: NAG-IINUM (drinking) is prenounced NAG-I-INUM.

The MAG- affixes express velitional - veluntary - action.

Past action is formed by NAG + me the verb root. This signals <u>completed</u> action and corresponds to the English past tense.

NAGSÚRAT	wrete
NAGT RABAHO	werked
NAG-ABÓT	arrived
NAGDALÄGAN	ran

<u>Present</u> action is formed by NAG+cv. CV stands for the reduplicated first syllable of the verb root, C being the first consenant, V the first vowel. NAG+cv signals an imperfective or <u>not-necessarily completed</u> action. From verb roots SURAT, BASA, DALAGAN:

NAGSUSURAT writing

NAGBABASA reading

NACDADALÁGAN running

Because all Bikel words beginning in a vewel are preceded by a glettal step, all verb reets are considered as beginning with CV. Thus, the first syllable of reets INUM (drink) and ABOT (arrive) is "?i" and "?a," each vewel preceded by a glettal step which is considered a consonant. From these reets:

NAG-IINOM drinking NAG-AABOT arriving with verb roots beginning in a consonant cluster the first vowel is reduplicated. From TRABAHO (work):

#### NAGTATRABAHAU working

The present action forms, signalling imperfective (notnecessarily completed) action, correspond to a number of English tenses. NAGSUSURAT AKO, depending on the context, could be translated in the following ways:

#### 1. <u>Simple</u> (habitual) present tense

NAGSUSÚRAT AKO AGA-AGA. I write every merning.

## 2. Past habitual ("used to/would")

KAN AKO SADIT PA, NAGSUSURAT AKO. When I was a child I used to write.

#### 3. Present progressive

NAGSUSURAT AKO NGUNYAN. I'm writing new.

#### 4. Past progressive

NAGSUSURAT AKO KAN MAG-ABOT KA. I was writing when you errived.

#### 5. Present perfect progressive

MADUWANG ORAS NA AKONG NAGSUSURAT. I've been writing for two hours.

#### 6. Past perfect progressive

MADUWANG ORAS NA AKONG NAGSUSURAT I had been writing for two hours

KAN MAG-ABOT KA. when you arrived.

Thus, NAG-+ cv can signal both habitual action (present and past) and continuing action (present and past). The term "present" is used for this form because its most frequent uses are for present actions - both habitual and continuing. Future action is formed by MA 'the verb root. This signals action that "will" happen or is "going to" happen.

MABASA	will read/ going to read
MÁ-INOM	will drink/ going to drink
MAKÁNTA	will sing/ going to sing

where English sometimes uses BE \_\_\_\_\_ING to indicate future meaning (e.g. "I'm graduating next June.") Bikel while assess uses only one affix indicating future action:\*

> MASAEN KA? Where are you going? MAHALE KA? Are you going out? MALÚWAS AKÓ. I'm going outside.

Imperative-plus action is formed by MAG- the verb root. One use of this affix is the command; "plus" stands for its other uses.

1. Commands.

MAG - , -UM- (an infix), and the verb root alone are all used to signal affirmative commands.

MAGSÚRAT KA. Write. MAG-INÓM KA. Drink. BUMALÍK KA. Come again. DUMÍGDI KA. Come here. TUKÁW. Sit down.

DAGOS. Come in.

\* There is a second kind of future action signaled by MAG \* cv, but this is used infrequently.

The preneuns KA and KAMO are used with MAG- and -UM- commands, but not when the root alone is used for the imperative.

For "Let's" (hortatory) commands, MAG- is used:

MAGDUMAN	KITA.	Let's go there.
MAGKAWAT	NA KITA.	Let's play new.

MAG- is used for all negative commanas:

daí ka magtukaw.	Den't makadam sit dewn.
DAI KA MAGTINDOG.	Den't stand up.

2. MAG- is used fellowing certain "pseudo" verbs (uninflected helping verbs):

TATAÓ KA NA PALAN MAGBÍKOL. Se yeu're speaking Bikel new!

PUÉDE KAMÓNG MAGDUMÁN PÍRME. You can always go there.

GUSTO KO MAN MAGITOM. I want to get tan (black).

3. MAG- fellows KAN ("when" with a past meaning), KON ("if/when" with a future meaning), MASKI ("even if" with a future meaning), and some other words which indicate that the action of the verb will occur in the future.

> KON MAGTARÁM KANG LÜWAY-LÚWAY MAKÁKASABÓT AKÓ. If yeu speak slewly, I'll be able to understand.

KON AKÓ MAGDIGDI, MAKARÍGOS AKÓ. When I come here I'll take a swim (batn).

The above example contrasts with "when" in the nabitual meaning:

KON AKO NAGDIDÍGDI NAGKÁKARÍGOS AKO. Whenever I come here I take a swim (bath).

NAG-AADAL AKO KAN MAG-ABOT KA. I was studying when you arrived.

4. MAG- fellews adjectives of manner:

MAGAYÓN KANG MAGBÁYLE. You dance beautifully.

MALUWAY SIYANG MACDALAGAN. He runs slowly.

Other volitional verb forms

Past action: An infix, -UMIN-, carries the same signal as NAGand indicates a completed (perfective) action. As with all infixes, -UMIN- follows the first consonant of the root or precedes the root if it begins in a vowel:

> KUMINU-Á AKÚNG BÓLA. I get a ball.

UMINIHA KAMÍ SAÍYA. We went with him.

Present action: MINA-, a prefix corresponding to NAG cv in the habitual present meaning is a stylistic adornment:

DAÍ PAGLINGAWAN AN A.B.C. GIN INUMON NA <u>MINA</u>DULOT NIN HÚSTONG KA-OGMAHAN.

Den't forget A.B.C. Gin, A drink that <u>gives</u> Real happiness. (from a radio commercial)

MINA-, colloquially, is used with KON to mean "whenever/ everytime..."

> KON MINATARAM AKÓ MAY SALÂ. whenever I speak I make a mistake.

MINA- may also be used to signal "was about to:"

MINADIGDI KUTA AKO PERO NAG-URAN. I was about to come, but it rained.

MINA-INÚM SIYA PERO NAHÚLOG. She was about to drink, but she fell down.

Used to express "to do X like a Y:"

MINALANGUY SIYA GARO SIRA. He swims like a fish.

MINAKATUROG AKO GARO LANA. I sleep like a log (oil).

NUTES ABOUT STRESS:

The present (imperfective) form, NAKAKA-+ verb reet, generally corresponds to "can" and "be able to."

NAKAKABASA SIYA KI MARHAY. He can read well.

NAKAKABIKOLNA SIYA. He can speak Bikel already.

The future form, MAKAKA " root, corresponds to "can (future)" and "will be able to."

IND'A SANA KON NU-ARÍN AKO MAKAKADUMÁN. I'm net sure when I can ge.

MAKAKALAKAW-LAKAW KITA SA AGA. We can walk around temerrew.

The imperative-plus form, MAKA root, is used in negative commands and other environments where MAG- is used (e.g. following "pseudo" verbs, KAN/KON/MASKI, adjectives of manner).

> DAI KA MAKALINGAW! Den't forget!

GUSTO KONG MAKA-ABOT ALAS DOS. I want to be able to arrive at 2 o' clock.

<u>MAKA-preferences</u>: some verbs show a preference for the MAKA-affixes over the MAG-affixes. Some of these are the verbs for "to learn" (MAKANU-OD in Naga, MAKA-UKOD in Legazpi), "to forget" (MAKALINGAW), "to understand" (MAKASABOT), "to remember" (MAKAROMDOM). Verbs of the senses, especially "to see" and "to hear" tend to occur most frequently with the MAKA-affixes.

STRESS: NAKAKA and MAKAKA are always stressed on the second syllable. NAKA- and MAKA- are stressed NAKA- and MAKA- only when the verb root has primary stress on the final syllable.

MA- verbs

MA- forms are intransitive and express involuntary (internal) action. The only kind of object MA- verbs take is a dative one:

> NADAGIT SIYA SAKO. She got angry at me.

NAMOMONDO AKO SAIYA. I miss her.

NASUSUPOG SINDA SAIMO. They're embarrassed in front of you.

MA- verbs generally correspond to the English "get/become/be adjective," e.g. "Get/become/be hungry."

The reduplicated syllable - CV - has a primary stress <u>Stress</u>: when the verb root has final stress. From WARA:

> getting lost/ gets lost NAWAWARA

# SUMMARY CHART OF MAJOR "ACTIVE" AFFIXES

The three series of affixes already presented all belong to a category that will be referred to as the ACTOR FOCUS. These affixes, aside from the category they belong to, will be referred to as "active." Of these "active" series the MAG- group may be remembered as "volitional", the MAKA- group as "potential" affixes, and the MA- group as showing "internal" (rather than external) action.

Basically, Bikel verb affixes can be divided into two groups, these which form "active" constructions and these which form "passive" constructions. Of the former there is one major category, the ACTOR FOCUS, and of the latter there are three categories, a brief description of which new follows.

#### "PASSIVE" CONSTRUCTIONS

While it is important to understand the meaning of TENSE and how it relates to the English verb system, the same idea is present to a much lesser degree in Bikel. The important thing in Bikel (corresponding to the key importance of "tense" in English) is FOCUS.

In English the inflections (\_\_\_\_\_\_\_\_ing, \_\_\_\_\_\_s) have to do with <u>time</u>. In Bikel the inflections (Mag-, -UM-, Nakaka-, -IN- etc.) have to do with <u>focus</u>.

Focus has to do with what is being talked about. Which affix is applied to the verb root depends on what is being talked about or focused on.

With the "active" affixes (MAG-, MAKA-, MA-) it is the deer of the action - the actor - that is being talked about, focused on. With the "passive" affixes it is the <u>receivor</u> of the action that is being focused on, talked about.

The following is the first of three major categories of "passive" construction in Bikel:

The infix -IN- alternates with PIG- in common usage with no difference in meaning.

The suffix -ON alternates with -A in affirmative commands. Hoots ending in q vowel (not followed by a glottal stop) add -HON or -HA:

GIBOHON, GIBOHA (from GIBO: make)

PAG- -ON is obligatorily used for negative commands.

#### OBJECT FOCUS (-ON) VS. ACTOR FOCUS (MAG-, MAKA-)

Object Focus affixes (OF) are used when the thing being talked about (focused on) is a <u>specific</u>, definite thing.

Actor Focus affixes (AF) are used when the thing being talked about (focused on) is a <u>non-specific</u>, indefinite thing.

- (AF) NAGBAKAL AKO NIN SIRA. I beughta fish.
- (OF) BINAKAL KO AN SIRA. I bought the fish.

An indefinite object in English is marked by "a," "some," or the plural. <u>A fish, some fish, and fish (either plural or fish in general) are all</u> indefinite, non-specific. In Bikol they will be marked by -NG (following and attached to a word ending in a vowel) or NIN (following a word ending in a consonant) or another non-specific object marker (such as KI, the preferred marker in Legazpi). These markers all indicate that the object is non-specific. The verb in such sentences will generally be affixed with ane of the MAG- series or MAKA- series.

A specific, definite object in English is marked by <u>the</u>, or a demonstrative (<u>this</u>, <u>that</u>), a pronoun (<u>her</u>, <u>them</u>)(<u>my</u> house). In Bikel the specific object will be marked by a special subject marker - AN, SU (the preference in Legazpi), SI (the preference in Naga) before common nouns. If the specific object is a person it will be marked by SI. The only specific objects which are not marked as such are the nominative pronouns (AKO, IKA, SIYA, KITA, KAMI, KAMO, SINDA) and the nominative demonstratives (INI, IYAN, ITO). The verb in Bikel sentences that talk about a specific object will bear (generally) one of the -ON affixes.

Consider the following examples:

ERIC

- (AF) NAGGIBO SIYANG KAWATAN. He made a toy.
- (OF) GINIBO NIYA AN KAWATAN. He made the toy.

The difference between the two sentences is one of <u>focus</u>. In the first sentence it is the action-doer (ACCOR) which is being talked about: SIYA. In the second sentence it is the specific object - AN KAWATAN - which is being talked about.

The pronouns are obligatorily different, since, in the first sentence, we have "He made a toy" and in the second "The toy was made by him."

Contrastive examples of <u>actor focus</u> (the focus is on the actor) and <u>object focus</u> (the focus is on the object ) :

The Object Focus affixes are generally used to express "X is the thing which is \_\_\_\_\_ed."

IYO IYAN AN LINUTO . That's what was cooked. PIGLUTO

INI AN BINAKAL ? Is this what was bought? PIGBAKAL

SIYA AN HINANAP MO? Is she the one you were looking PIGHANAP fer? ("who was looked for by you")

This last sentences shows that Object Focus can also deal with persons. For the sake of simplification it is not harmful to think that OF generally deals with <u>objects</u>, things.

STRUCTURAL DIFFERENCES BETWEEN ACTOR FOCUS AND OBJECT FOCUS SENTENCES

First, all sentences with a true verb will have a <u>specific</u> subject. The subject may be one of the nominative pronouns or demonstratives or a noun (or part of speech used as a noun) marked by a subject marker. The subject markers in standard Bikel are SI before proper

names and AN before common nouns (or words used as nouns). In Naga SI is used to mark identified common nouns; in Legazpi SU is used to mark identified common nouns.

So, either the subject is (1) a pronoun (AKO, IKA, etc. INI, etc.) or (2) it is <u>marked</u> by a subject marker (SI, SU, AN)

- 2. When MAG- or MAKA- (or MA- intransitive) verbs are used, the subject is the one <u>doing</u> the action. If there is an object it is generally a non-specific one, and <u>marked</u> as such by -NG, or NIN (or KI, as in Legazpi).
- 3. When -ON or MA- (transitive) verbs are used, the subject is the <u>recipient</u> of the action. The <u>doer</u> of the action is either (1) one of the genetive sets of pronouns (KO, MO, etc. KA-INI etc.) or (2) a noun <u>marked</u> by KAN (common noun)

or NI (proper name).

There are three structural differences between AF and OF full sentences: (1) affixation (MAG-,MAKA- vs. -ON, MA-) (2) action deer (nominative vs. genetive) (3) object marker (non-specific vs. specific)

The fourth and last focus category of Bikel is the BENEFACTIVE FOCUS (BF). It has three general uses:

(1) It expresses "person for whom" something is done.

IBINAKAL MIYA AKO(KI PAN. ) (Leg.) (NIN TINAPAY) (Naga) He bought some bread <u>for me</u>.

IDADAHÁ TA KANG KAWÁTAN. I'll bring you (for you) a toy.

In the Hikel verb system there are four focus categories. One of them forms "active" constructions and focuses on the door of the action - the actor. (ACTOR FOCUS).

The other three categories form "passive" constructions and focus on the recipient of the action.

For each of the four categories there is one set of "volitional" affixes and one set of "potential" affixes.

There is one man set of affixes used intransitively and expressing internal action (MA-).

Additional affixes not presented all belong in one of these four categories. Other affixes which may attach themselves to these already presented (e.g. MAPA-, NAGPA-) will also fall into one of the four categories.

For already <u>identified</u> nouns Naga Bikel uses <u>SI</u> and Legazpi Bikel uses <u>SU</u> before common nouns, <u>SU</u> and <u>Legazpi</u>.

(SI)(Naga) HAEN AN AKI KO? Where's my child? (SU)(Leg.)

Just as there is only one subject per clause, there can be only one subject marker per clause. If the subject of a clause is not a pronoun (personal or demonstrative), then it must be <u>marked</u> by one of the subject markers.

The nominative agent marking common nouns is AN/SU (Leg.)/SI (Naga). The genetive agent marking common nouns is KAN.

Enclitic particles are particles which may not occur alone or sentence initial. These particles are of extremely high frequency and occur quite liberally throughout any colloquial conversation. Singly and in combination they are the spices that flavor normal utterances.

NA "already, new..(<u>net</u> in the adverbial sense) MASINI KA NA? Are you going to go to the movies new?

### PA- Causative

PA- is a causative particle used in both active and passive constructions meaning "cause to \_\_\_\_\_" and generally translated as "let/ ask to/ make/ have/ allow to \_\_\_\_\_." This is a quite productive affix.

> PADISPONÉRA NA SIYÁ NIN MIKE. Let him <u>get</u> a microphone.

### PLURALITY

NOUNS: The plural marker MGA (pronounced MANGA) precedes nouns:

MGA BURAK flowers

MGA AKI children

ADJECTIVES: Though infrequent, a reduplication of the first syllable of adjective roots expresses plurality:

KAGAGAYON KAN MGA BIKOLANA! How beautiful Bikol girls are! oun-eastile

VERBS: When KITA, KAMI, or SINDA refers to more than two people an optional plural marker -RV- is added to the root. R plus the first vowel is infixed after the root's first syllable:

MAKARAWAT NA KITA? Shall we play new?

TUMIRINDOG NA KAMO, MGA AKI. Stand up new, children.

NAGDADARALAGAN SINDÁ. They're running.

When the root begins in L, -RV- precedes the root and, where cv is called for, is reduplicated rather than the cv of the root.

> MARALANGOY NA KAMO? Are you all going to swim now?

This -RV- indicating a plural agent is of frequent use, though not obligatorily used.

\* MGA is an accepted abbreviated form of MANGA

## DIRECTIONAL MARKER: SA

SA, depending on the context, can be used in a locative sense to mean "at, in, to, on, from, by, with."

NAGBAKAL SIYA SA SA-OD. (Leg.) SADAN. (Naga) He bought at the market.

NAGESTAR SIYA SA HARONG MI. He lived in our house.

NAGHALAT SIYA SA KANTO. He waited on the corner.

MEXBORRENDEN & REDMATCHEX COMPANY

NAGSUBLI SIYA SA GUHANG. He berrewed from the old man.

NAG-AGI SIYA SA MAY SIMBAHAN. He passed by the church.

NAG-IBA SIYA SA AKI. He went with the little bey.

### POLITE FORMS

<u>PÔ</u> (sir, ma'am)is much used in the Naga area to show respect. When an utterance is not heard and needs to be repeated, the listener's PÔ? (Sir/Ma'am?) or ANÓ PÔ? (What, sir/ma'am?) is considered much more polite than merely saying ANÓ? (What?).

In the Legazpi area TABÌ ("please") is the most frequent polite form. The equivalent of PÔ? and ANÓ PÔ? in Legazpi is TABÌ? (Please? i.e. Would you please repeat what you said.) and ANO TABÌ? (Pardon me, what?).

In imperatives MAKI- and PAKI- prefixed to verbs add politeness:

PAKISIRAHA MAN TABÌ AN PINTÔ. Weuld yeu please close the deer?

Next on the scale would come -

ERIC

SIRAHA MAN TABÌ AN PINTÔ. Please close the door.

The inclusion of MAN or DAW softens countands:

SIRAHA MAN AN PINTO. DAW Would you close the deer?

The placement of PO, along with tone of voice, can show either respect or disrespect.

MAHIGUSON KA PÔ DAÁ MARAY. They say you're a hard worker! MAHIGUSON KA DAÁ MARAY PÔ.

The second sentence, with different intenation and different placement of PO can be used to make fun of someone.
